- Involved in work that contributes towards the transformation of the planning sector.

1. A completed nomination form and supporting documents for each nomination is required.
2. The nominator's details as per the form and a person may nominate themselves.
3. The nominee details as per the form, SACPLAN registration is mandatory.
4. Signed nomination acceptance letter from the nominee.
5. Motivation by the nominator must be submitted, not exceeding 1200 words, with examples of excellent, innovative concepts, projects, and programs.
6. A short curriculum vitae of the nominee not exceeding two pages.

**Failure to comply with the above-listed requirements, may result in the disqualification of the nomination.**
